Supervisor William Potter opened the regular town board meeting at 7:00 PM with the Pledge of Allegiance.

## **REPORTS:**

- -Code Enforcement Officer John Howland stated there were no permits issued in the month of May.
- -Oswego County Legislator Milferd Potter read his report, the County agenda can be found on the Oswego County Website.
- -Water Operator-Eric Pappa submitted his report via email.
  - Average water usage is between 18,000 and 19,000 gallons per day.
  - BAC T residual is currently averaging .50 per day.
  - BAC T testing came back from Converse labs and is in compliance.
  - Highway Superintendent Henry has had debris removed and had lawns mowed around the well field.
- -Highway Superintendent Douglas Henry handed in the equipment repair cost report for May and went over the highway bills.
  - Paving is tentatively scheduled to start June 24, weather permitting.
  - The highway department is currently cutting trees on Beecherville Rd.
- Dog Control Officer-Steven Cronk brought a dog in to see if anyone recognized it and might know the owner. The dog was found wandering in Orwell. Councilman Jones took a picture of the dog to post on the Town's Facebook page.
- -Old Home Day was a success. The changes this year brought in a bigger crowd. Supervisor Potter expressed gratitude to Chairperson LouAnn Stone and Treasurer Rose Graham for their hard work. LouAnn and Rose are stepping down this year.

- -The Oswego County Supervisors Association met to discuss the unfair distribution of sales tax within the county. A letter was drafted asking the County Legislative body to re-evaluate the sales tax distribution to make it more equitable for all municipalities.
- -Jason Rossman will be repairing the vestibule soon.
- -A motion was made by Councilman Ryan Jones and seconded by Councilman Nicholas Marshall to accept the quote from E&V for the air conditioning installation. (5 Ayes) Motion carries.
- -Supervisor Potter is acquiring quotes for Propane. He has received a quote from Glider and is waiting on a quote from E&V.
- -A motion was made by Councilman Ryan Jones and seconded by Councilman David Lake to purchase a climbing structure to add to the existing playground structures. The playground equipment will be purchased from BYO Playground Equipment. (5 Ayes) Motion carries.
- -Shirley Downes complimented the Town Board on a job well done.
- -Supervisor Potter has received the certificate from the health department for the kitchen inspection. He has also received notice that the town's equalization rate is 100%.
