# ADOPTS PROVISIONS OF EXECUTIVE ORDER 202.83 SUSPENDING THE REQUIREMENTS OF RENEWAL APPLICATIONS AS A CONDITION TO GRANTING EXEMPTIONS UNDER SECTIONS 459-C AND 467 OF

#### THE REAL PROPERTY TAX LAW

Supervisor William Potter offered the following resolution, which was seconded by Councilman Jeffrey Graham

**WHEREAS**, the Governor of the State of New York by Executive Order No. 202 dated March 7, 2020, declared a state disaster emergency for the entire State of New York; and

**WHEREAS,** both travel-related and community contact transmission of COVID-19 have been documented in New York State and are expected to continue; and

WHEREAS, pursuant to Section 29-a of Article 2-B of the Executive Law, New York State

Governor Andrew Cuomo did issue Executive Order 202.83 dated December 18, 2020, 2020, which authorized, by local option, the governing body, to adopt the provisions of that Executive Order 202.83, which temporarily suspends or modifies, subdivisions 7, 7-a and 8 of section 459-c of the Real Property Tax Law and subdivisions 5, 5-a, 5-b, 5-c and 6 of section 467 of the Real Property Tax Law. The COVID-19 Emergency Eviction and Foreclosure Prevention Act of 2020 (Chapter 381 of the Laws of 2020) was signed into law by Governor Cuomo on December 28 mandating the provisions.

**NOW THEREFORE BE IT RESOLVED,** that pursuant to Executive Order 202.83 issued by New York State Governor Andrew Cuomo and Chapter 381 of the Laws of 2020, the Town Board of the Town of **ORWELL** hereby authorizes the Assessor to request an application where he or she has reason to believe that the applicant may have changed his or her primary residence, added an additional owner to the deed, transferred the property to a new owner, or died, and be it further

**RESOLVED,** that the Town Clerk is hereby directed to forward a copy of this resolution to the Assessor; and be it further

**RESOLVED**, that all Town Hall Departments may review and obtain a copy of this resolution from the electronic storage device and if needed, a certified copy of same may be obtained from the Office of the Town Clerk.

# **REPORTS:**

A) CEO John Howland emailed his 2020 Annual Report and it is on file in the Town Clerk's Office. Four were issued in the month of December. There will be a fire inspection in a couple of months.

B) Oswego County Legislator Herb Yerdon went over the current COVID-19 report. He also shared news about the County Career Center receiving an award for helping veterans in all military branches ranging in age from 21-84 find jobs from July 2019- June 2020. Oswego County BOE will be closed until January 19<sup>th</sup> due to COVID and all Oswego County offices will be closed Monday January 18<sup>th</sup> for Martin Luther King Day. Oswego County department of Health is encouraging those 65 and older to get the high-dose flu vaccine. Legislator Yerdon also submitted information about the COVID-19 vaccine. All informational packets are on file in the Town Clerk's office.

E) Water Operator Eric Pappa had no report. He turned water on for one person and the Spring House is back to a normal level and the Town is using about 13,000 gallons of water per day.

F) Highway Superintendent Henry handed in the equipment repair cost report for December and went over the highway bills.

G) Tug Hill Representative Paul Baxter read his report. The Tug Hill Commission is still operating at 50% or less occupancy. Zoom is looking like it is going to be a constant in the world of meetings. Contractors to help facilitate zoom meetings for towns are needed. The Tug Hill website has been updated and reorganized. Inter-municipal Agreement was renewed in November and needs to be agreed upon at the Town level.

- A motion was made by Councilman Jeffrey Graham and seconded by Councilman David Lake to approve the Inter-municipal agreement. ( 4 Ayes) Motion carries

H) NOCA - NOCA representative Bob Trainham submitted his report. All providers and three office staff have all received the COVID-19 vaccine. Upon reviewing the 2020 budget's actual income vs expense NOCA only used less than \$25,000 out of the fund balance instead of the estimated \$65,000. NOCA received 12 calls more than last year. Throughout the year only a couple of staff members contracted COVID and not from Oswego County.
