The public hearing opened at 7pm. David Powers from Barton & Loguidice read the handout outlining the Town's water system improvements project. The Town is still in need of an alternate water source to fix the issues with the exiting water source capacity. The three potential alternatives discussed are still viable options and are being pursued starting with groundwater investigations. The project will benefit the community by providing a reliable year round water source and improving existing infrastructure. The Town will be submitting a CDBG funding application by the deadline in March, requesting \$1,250,000 in grant. There is no local match amount for the CDBG program. Resolution #5-2021, Resolution #6-2021, Resolution #7-2021, and Resolution #8-2021 were all passed unanimously. No public attended the public hearing and the regular meeting opened at 7:15pm with the pledge of allegiance.

BOND RESOLUTION DATED FEBRUARY 9, 2021 OF THE TOWN BOARD OF THE TOWN OF ORWELL AUTHORIZING THE ISSUANCE OF NOT TO EXCEED \$3,000,000 AGGREGATE PRINCIPAL AMOUNT OF SERIAL GENERAL OBLIGATION BONDS TO **FINANCE** THE CONSTRUCTION INSTALLATION OF IMPROVEMENTS TO WATER SUPPLY SYSTEM FOR THE TOWN OF ORWELL WATER DISTRICT AT AN ESTIMATED MAXIMUM COST OF \$3,000,000, LEVY OF TAX IN ANNUAL INSTALLMENTS IN PAYMENT THEREOF, THE EXPENDITURE OF SUCH SUM FOR SUCH PURPOSE, AND DETERMINING OTHER MATTERS IN CONNECTION THEREWITH.

WHEREAS, the Town Board of the Town of Orwell (the "Town") caused a Map, Plan and Report (the "Report") to be prepared outlining all aspects of a proposed water system improvements for the Orwell Water District (the "Water District"), together with an estimate of the cost thereof, to be prepared by Barton & Loguidice, D.P.C., competent engineers duly licensed by the State of New York (the "Engineer"); and

WHEREAS, upon completion of the Report and the filing thereof in the office of the Town Clerk, the Town Board of said Town adopted an order calling a public hearing thereon and caused a notice of such hearing to be published and posted in the manner provided in section 193 of the Town Law of the State of New York (the "Town Law"); and

WHEREAS, the order adopted described the estimated expense of the proposed improvements

to be **Three Million Dollars** (\$3,000,000.00) and stated that the Town Board would meet to hear all persons interested in the subject matter thereof on the 10th day of November, 2020, at 6:45 p.m. at the Town Hall, 1999 County Route 2, in the Town; and

WHEREAS, a public hearing was held at the time and place aforesaid in the manner described at which time all persons interested in the subject matter were given an opportunity to be heard and the proposed improvements, the estimated costs of the improvements, and the estimated annual cost to the typical property/typical home were discussed; and

WHEREAS, at a regular meeting of the Town Board held on November 10, 2020, the Town Board as lead agency adopted a resolution determining that the Purpose (as herein defined) is a "Type 1 Action" under the New York State Environmental Quality Review Act and the regulations adopted pursuant thereto by the Department of Environmental Conservation of the State of New York and further determined that the Purpose will not have a significant effect on the environment, and that a negative declaration be issued for the Purpose; and

WHEREAS, at a regular meeting of the Town Board held on November 10, 2020, the Town Board adopted a resolution (the "Order") determining that the evaluation and construction of the improvements described in the Report are in the public interest and, the preparatory to solicitation of competitive bids relative to such construction, directing the Town's Engineer to prepare definite plans and specifications and to make a careful estimate of the expense of the aforesaid improvements and, with the assistance of the Town Attorney, to prepare a proposed contract for the execution of the work; and

WHEREAS, the Town Clerk recorded a copy of the Order in the office of the County Clerk of the County of Oswego as required under Section 195 of the Town Law; and

WHEREAS, the Approving Resolution was adopted subject to permissive referendum; and

WHEREAS, notice of the adoption of the Order (the "Permissive Referendum Notice") was published in the official newspaper of the Town and posted on the Town bulletin board pursuant to the Town Law; and

WHEREAS, no petition requesting a vote on the Order was received by the Town within thirty days of the date of the publication of the Permissive Referendum Notice; and

WHEREAS, the Town Board desires to adopt this Bond Resolution to approve the Purpose and the issuance of bonds and bond anticipation notes to finance the cost of the Purpose;

NOW THEREFORE BE IT RESOLVED, by the Town Board of the Town (by favorable vote of not less than two-thirds of all the members of the Board) as follows:

<u>Section 1</u>. The Town is hereby authorized to issue its serial general obligation bonds (the "Bonds") in the aggregate principal amount of not to exceed \$3,000,000 pursuant to the Local Finance Law of New York, in order to finance the class of objects or purposes described herein.

<u>Section 2</u>. The class of objects or purposes to be financed pursuant to this resolution is the construction, reconstruction and additions to the District's water supply system, including land, rights in land, the acquisition of equipment, machinery or apparatus and the payment of costs incidental thereto (collectively, the "Purpose"); and

Section 3. It is hereby determined and declared that (a) the maximum cost of the Purpose, as estimated by the Town Board, is \$3,000,000, (b) no money has previously authorized by the Town Board to be applied to the payment of the cost of the Purpose and (c) the Town plans to finance the cost of the Purpose entirely from funds raised by the issuance of the Bonds and bond anticipation notes hereinafter referred to and available grants.

Section 4. It is hereby determined that the Purpose is one of the class of objects or purposes described in Paragraph 1 of Section 11.00 of the Local Finance Law, and that the period of probable usefulness of the Purpose is forty (40) years. The proposed maturity of the Bonds authorized herein will be in excess of five (5) years.

<u>Section 5</u>. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the sale of the Bonds, including renewals of such notes, is hereby delegated to the Supervisor of the Town, the chief fiscal officer.

Section 6. The power to further authorize the issuance of the Bonds and bond anticipation notes and to prescribe the terms, form and contents of the Bonds and bond anticipation notes, including the consolidation with other issues and the use of substantially level debt service, subject to the provisions of this Resolution and the Local Finance Law, and to sell and deliver the Bonds and bond anticipation notes, is hereby delegated to the Supervisor of the Town. The Supervisor of the Town is hereby authorized to sign and the Town Clerk is hereby authorized to attest any Bonds and bond anticipation notes issued pursuant to this Resolution, and to affix to such Bonds and bond anticipation notes the corporate seal of the Town.

Section 7. The faith and credit of the Town of Orwell, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such Bonds and bond anticipation notes as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such obligations becoming due and payable in such year, to the extent the necessary funds are not provided from other sources. There shall be levied annually on all taxable real property in the Town, a tax sufficient to pay the principal of and interest on such obligations as the same become due and payable, to the extent the necessary funds are not provided from other sources.

Section 8. This Resolution shall constitute the declaration of the Town's "official intent" to reimburse expenditures authorized by Section 1 with proceeds of the Bonds and notes, as required by United States Treasury Regulation Section 1.150-2. The Town shall not reimburse itself from the proceeds of the Bonds or notes for any expenditures paid more than sixty days prior to the date hereof, unless specifically authorized by Section 1.150-2 of the Treasury Regulations.

Section 9. This Resolution, or a summary hereof, shall be published by the Town Clerk together with a notice in substantially the form prescribed by Section 81.00 of said Local Finance Law, and such publication shall be in each official newspaper of the Town. The validity of the Bonds or of any bond anticipation notes issued in anticipation of the sale of the Bonds may be contested only if such obligations are authorized for an object or purpose for which the Town is not authorized to expend money, or the provisions of law which should be complied with at the date of publication of this Resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication; or if said obligations are authorized in violation of the provisions of the Constitution.

<u>Section 10</u>. The firm of Barclay Damon LLP is hereby appointed Bond Counsel of the Town in connection with the bonds and notes herein authorized.

<u>Section 11</u>. This Resolution shall take effect immediately.
