Supervisor Potter opened the meeting at 7:00pm with the pledge of allegiance.

### **REPORTS:**

- A) CEO John Howland had no report.
- B) Oswego County Legislator Herb Yerdon arrived at 7:30 and gave his report
  - As of March 8<sup>th</sup> 157,588 COVID-19 tests were done in Oswego County.
    - 6,482 were positive
    - 148,954 were negative
    - 179 are currently still active positive
    - 6,214 have recovered
    - 89 deaths reported by the NYSDOH
    - 494 in mandatory isolation
  - Detailed information can be found online at health.oswegocounty.com/covid-19 or call the hotline at 315-349-3330 weekdays from 8:30am-4pm and weekends from 8:30am- noon.
  - People age 60 and over are now eligible to receive the COVID-19 vaccine.
  - The Oswego County Health Department has released their rabies clinic schedule for 2021. All clinics are held on Wednesday evenings from 6-8pm and appointments must be made in advance. Appointments can be made by calling 315-349-3564. A limited number of appointments will be available. The suggested donation is \$7 per pet.

- C) Dog Warden- No report.

- E) Water Board- No report
- F) Highway Superintendent Henry read the bills and repair costs for February. State put \$10 Million into the CHIPS funding to reimburse the 20% they took last year. The Town should be receiving paperwork soon to apply for the 20% or roughly \$26,000 the state took last year. As of right now the Town will receive the usual amount of money from CHIPS, PAVE-NY, and Extreme weather.
- G) Tug Hill Representative Verne Sundet filled in for Representative Baxter and read his report. The Tughill Commission is still operating at 50% capacity and probably will for the foreseeable future. The Governor extended his executive order regarding the allowance of zoom meetings. March 15<sup>th</sup> there will be a zoom meeting for the Tughill Commission. By April they are hoping to resume in person. The Tughill Commission website has training workshops available.
- H) NOCA Overall they are doing well. The number of COVID-19 calls have dropped however due to the multitude of symptoms for COVID-19, they are still required to clean frequently. Billing income is low. Insurance companies are behind on their reimbursements and are trying to reimburse with a credit card that in turn is costing to use. NOCA is still looking for help. The wage for EMT's keeps getting raised and NOCA can't compete with larger corporations.

### **DISCUSSION:**

A & B) Dustin Clark went over the Groundwater Investigations Authorization Amendment. It is the first step in starting investigations for a new groundwater source. Up to \$250,000 is allowed to be spent to do so. Ideally they are hoping to find a groundwater source that can support a well producing 50 gallons/minute. Two wells would be even better. The investigation will begin on the Town's existing well site and will then go to the multiple properties within and around the Town's water system. If the weather cooperates investigations will begin next month. The Town Board approved the Groundwater Investigations Authorization Amendment No. 1 and passed Resolution # 11-2021. The Town of Orwell has an existing Wellhead Protection Plan however a new one may be required depending on where the new well is located.
