Supervisor Potter opened the Public hearing portion of the meeting at 7:00pm with the pledge of allegiance. No public had any comments in relation to the public hearing.

Dustin Clark from Barton & Loguidice went over the work currently being done on the water project. 7 test borings in total were done at 4 properties. 2 at the Town's gravel pit property and water was found. However it has a gray clay in it that makes the water cloudy. A water quality test was performed and results are not back as of this meeting. Similar test borings were done on the existing well property and the water is clear and running at about 60-65 gallons per minute. Although its considered shallow at only 30 ft, it is estimated to be 5 feet deeper than the existing well and they hit bedrock. The well drillers don't feel going any deeper will improve the flow of water as there usually isn't significant water in bedrock. David Potter from the water board commented that the last time the Town dug a well they went into the bedrock and was unsuccessful in finding more water. A surface water test will need to be done to test the quality of the water. The following 4 Resolutions were passed in conjunction with the reapplication for the CDBG grant. REPORTS:

- A) CEO John Howland had no report. 2 building permits have been issued in the last month.
- B) Oswego County Legislator Herb Yerdon arrived at 7:26 and gave his report
 - As of July 12th 2021, 236,230 COVID-19 tests were done in Oswego County since March 2020.
 - 8,136 were positive
 - 225,025 were negative
 - 7 are currently still active positive
 - 8,038 have recovered
 - 93 deaths reported by the NYSDOH
 - 16 in mandatory isolation
 - Detailed information can be found online at health.oswegocounty.com/covid-19 or call the hot-line at 315-349-3330 weekdays from 8:30am-4pm and weekends from 8:30am-noon.
 - In response to multiple complaints about the DMV in Pulaski, Legislator Yerdon inquired about their current schedule and it is as follows: Walk ins are Tuesday and Thursday, and appointments are Monday, Wednesday, and Friday until August when they will switch to walk ins on Monday, Tuesday, Thursday, and Friday and appointments on Wednesday.
 - CNY Regional Planning and Development Board continues to encourage residents in Oswego County to complete the broadband survey.
 - Oswego County Health Department is reminding residents that lyme disease is on the rise and is seeing a significant increase of 67%. People are encouraged to take precautions and to check themselves as well as pets and children when coming in from outside.
 - United Way of Greater Oswego County is launching a vaccine incentive program for those 12-25 years old to encourage them to get the COVID-19 vaccine. County residents between the age of 12-25 who receive the vaccine after July 12th 2021 will be entered into a drawing. First prize is an Apple iPad air, second prize is a \$250 walmart or amazon giftcard, and third prize is a \$100 giftcard for Oswego Cinema. The drawing will be held July 30th, August 27th, and September 17th.
 - The Oswego County Solid Waste Department at the Bristol Hill Landfill is doing a paper shredding event from 9am-noon August 7th 2021. Oswego County residents are allowed to bring up to 5 banker boxes of papers to be shredded free of charge.
 - Senior Farmers market coupon distribution for 2021 will begin July 12th and go until July 21st. More information is located in the Town Clerk's office.

- C) Highway Superintendent Henry read the bills and repair and maintenance costs for the month of June. The tractor is broken and needs extensive repairs. Supervisor Potter ask Superintendent Henry if the tractor was worth fixing or if they should get a new one. Superintendent Henry said the tractor was cheaper to fix than to get a new one. Councilwoman Steele suggested that the Town should budget an equipment reserve fund for the Town Highway Department that would aid in purchasing a new tractor within the next 5 years or more. Superintendent Henry received the new floor drain and is happy with the quality of it. Upon looking at its construction he feels he can obtain the materials needed to construct the other needed floor drains and have the Town Highway employees make them cheaper than they are to buy. The Town Board agreed that sounded like a good idea.
- D)Tug Hill Representative Paul Baxter read his report as written.
- E) NOCA Financially NOCA is holding their own however they are still short staffed. They took on 2 new paramedics in July and one has already left for a higher paying position. Their billing department is only one person and she has put in her resignation notice effective September 30th. NOCA is being forced to go to a commercial billing company. They are currently \$4,000 over budget in fuel costs however they are also 180 calls ahead of last year.

DISCUSSION:

A) Supervisor Potter has submitted the American Rescue Plan Application. \$119,000 is projected to be awarded this year and another \$119,000 next year. There are many restrictions on what the money can be used for so more information and instruction is needed before a decision can be made on how to spend it.
