Supervisor Potter opened the special meeting to discuss the approval of the Cogswell Free Public Library Trustees at 5:00 PM. In the process of reviewing how many trustees the library board is supposed to have, it was discovered that many things have not been done as they should be. One of those things is the Town Board must approve all Library Board trustees.

Representatives from North Country Library Systems (NCLS) were present to provide information as well as answer questions. NCLS updated the library's board of trustees' bylaws requiring all trustees to reside in the Town of Orwell as well as requiring them to sign an Oath of Office within 30 days of approval of their appointment.

Gretchen Flick, Library Trustee President, introduced herself. Gretchen is a retired teacher of 21 years, has lived in the Town of Orwell for many years, and has been an active member of the library since 2020. Only recently was she given the title as president. -A motion was made by Councilwoman Jessica Steele and seconded by Councilman Ryan Jones to approve Gretchen Flick as a Cogswell Free Public Library Board Trustee. (5 ayes) motion carries.

Christina Burns, Library Board Trustee candidate, introduced herself. She is a nurse who currently works with a Medicare Advantage company. She has lived in the Town of Orwell for 17 years.

-A motion was made by Councilman Ryan Jones and seconded by Councilwoman Jessica Steele to approve Christina Burns as a Cogswell Free Public Library Board Trustee. (5 ayes) motion carries

Jane Nemier, Library Board Trustee candidate, introduced herself. She is retired from South Jefferson High School and is widowed. She has lived in Orwell for 3 years. -A motion was made by Councilman William Garvin and seconded by Councilman David Lake to approve Jane Nemier as a Cogswell Free Public Library Board Trustee. (5 ayes) motion carries

Kathleen Melia, Library Board Trustee candidate, introduced herself. She had a camp in Orwell for many years and built a house to live in full time 11 years ago. She is a retired health safety and environmental director. She currently runs the Redfield Food Pantry and has for the last 7 years.

-A motion was made by Councilman William Garvin and seconded by Councilwoman Jessica Steele to approve Kathleen Melia as a Cogswell Free Public Library Board Trustee. (5 ayes) motion carries NCLS is assisting local libraries with a broadband project. With this project the library will receive upgraded routers as well as public access computers. The grant could cut the cost to the library up to 50% for the computers and up to 90% for the broadband upgrades and installation. The Town of Orwell owns the building the library is housed in so Board approval is needed to move forward with the project.

-A motion was made by Councilman Ryan Jones and seconded by Councilman William Garvin to approve a letter of support for the broadband project for the library. (5 ayes) motion carries

The Town Board reviewed the projected new design and made some suggestions. Gretchen Flick has received a few quotes for some of the upgrades but is still waiting on others. The project is projected to be completed in 2025.
