## EXTRACT OF MINUTES OF MEETING OF THE TOWN BOARD ADOPTING RESOLUTION AND ORDER

At a regular meeting of the Town Board of the Town of Orwell, in the County of Oswego, in the State of New York on the 10<sup>th</sup> day of October 2023:

Councilman William Garvin presented the following resolution and moved that it be adopted:

# RESOLUTION #11-2023-ORDER AUTHORIZING INCREASE IN COST OF THE CONSTRUCTION OF IMPROVEMENTS AND EXPANSION OF THE ORWELL WATER DISTRICT PURSUANT ARTICLE 12 SECTION 202-B OF TOWN LAW OF THE STATE OF NEW YORK

WHEREAS, the Town Board of the Town of Orwell (the "Town") caused a Map, Plan and Report (the "Report") outlining all aspects of proposed water system improvements for the Orwell Water District (the "Water District"), together with an estimate of the cost thereof, to be prepared by Barton & Loguidice, D.P.C., competent engineers duly licensed by the State of New York (the "Engineer"), which Report has been duly filed with the Town Clerk in accordance with the requirements of Article 12-A of the Town Law; and

WHEREAS, an Order was duly adopted by the Town Board on November 10, 2020 (the "2020 Order"), reciting the filing of the Report, the improvements proposed, the boundaries of the proposed Water District, the proposed method of financing, the fact that the Report describing the same were on file in the Town Clerk's Office for public inspection, and stating all of the matters required by the Town Law to be stated, and specifying February 18, 2021 as the date, at 7:00 p.m. on said day as the time, at the Town Office, as the place, where the Town Board would meet and consider the Report, and to hear all persons interest in the subject thereof concerning the same (the "2020 Public Hearing"), and to take such action thereon as is required or authorized by the Town Law; and

**WHEREAS**, notice of the 2020 Public Hearing was duly published and posted as required by the Town Law (the "2020 Notice of Public Hearing"); and

**WHEREAS,** the 2020 Order stated that the maximum amount proposed to be expended to pay for the Project was \$3,000,000.00; and

WHEREAS, pursuant to Article 8 of the Environmental Conservation Law and the regulations contained in 6 NYCRR Part 617 adopted pursuant thereto by the Department of Environmental Conservation of the State of New York, (hereafter "SEQRA"), the Town Board by resolution duly adopted on November 10, 2020 (the "SEQRA Resolution"), and based on its examination of the Environmental Assessment Form ("EAF"), the criteria set forth in Sections 617.11 and 617.6 of the regulations, and such further investigation as the Town Board deemed appropriate, determined that the Project will not cause a significant impact on the environment, and the Town Board will not require the preparation of an environmental impact statement and ordered that a negative declaration is to be prepared and circulated in accordance with the requirements of SEQRA and the regulations thereunder; and

**WHEREAS**, due to generally increased costs of labor and materials, the maximum amount now proposed to be expended for the Project is \$3,900,000.00, an increase of \$900,000; and

**WHEREAS**, the order adopted described the estimated increase in cost of the now proposed improvements to be **Three Million Nine Hundred Dollars** (\$3,900,000.00) and stated that the Town Board would meet to hear all persons interested in the subject matter thereof on the 10<sup>th</sup> day of October 2023, at 7:00 p.m at the Town Hall, 1999 County Route 2, in the Town; and

WHEREAS, a public hearing was held at the time and place aforesaid in the manner

described at which time all persons interested in the subject matter were given an opportunity to be heard and the proposed increase in the maximum estimated costs of the improvements were discussed; and

**NOW, THEREFORE,** upon the evidence given at the public hearing described herein, it is hereby determined as follows:

## NOW THEREFORE, BE IT RESOLVED AS FOLLOWS:

- (1) That the Notice of the Public Hearing was published and posted as required by law and was otherwise sufficient.
- (2) That all of the property and property owners within the proposed district are benefited thereby.
- (3) That all of the property and property owners benefited by the proposed district are included within the limits of the proposed district.
  - (4) That the formation of the proposed district is in the public interest.

That based upon 1 through 4 above, this Board does hereby approve the increase in the maximum amount to be expended for the formation of the Town of Orwell Water District to THREE MILLION NINE HUNDRED THOUSAND (\$3,900,000.00) DOLLARS; and

**BE IT FURTHER RESOLVED,** that this Resolution is SUBJECT TO PERMISSIVE REFERENDUM and the Town Clerk and Attorney to the Town Board are hereby directed to prepare necessary notices and publish same as required by law.

# NOTICE OF ADOPTION OF RESOLUTION SUBJECT TO PERMISSIVE REFERENDUM

At a special meeting held on 10<sup>th</sup> day of October 2023, the Town Board of the Town of Orwell, New York (the "Town") duly adopted a resolution and order, an abstract of which follows, which resolution and order is subject to a permissive referendum in the manner provided in subdivision 3 of Section 209-e of the Town Law of the State of New York. Said resolution shall not take effect until thirty (30) days after the date of its adoption, or until approved by the affirmative vote of a majority of the owners of taxable real property situate in the Orwell Water District of the Town of Orwell in the Town as shown upon the latest completed assessment-roll of the Town filed with the Town Clerk, voting on such proposition, if within thirty (30) days after the adoption of the resolution, there is filed with the Town Clerk a petition signed, and acknowledged or proved, or authenticated by electors of the Town qualified to vote upon a proposition, in number equal to at least five per centum of the total number of such owners, or by one hundred of such owners, whichever is the lesser. For this purpose, a corporate owner of such

taxable real property shall be considered one owner for the purposes of a petition requesting a referendum and shall be entitled to one vote to be cast by an officer or agent of the corporation or other duly authorized person designated by appropriate resolution of such corporation.

#### ABSTRACT OF RESOLUTION AND ORDER DATED OCTOBER 10, 2023

The following is a summary of a resolution adopted by the Town Board of the Town of Orwell, Oswego County on September 12, 2023. Said resolution (A) determined that it was in the public interest to authorize an increase in the maximum amount to be expended for the construction, reconstruction and additions to the water supply system improvements for the Orwell Water District, including land, rights in land, the acquisition of equipment, machinery or apparatus and the payment of costs incidental thereto of the Town of Orwell to \$3,900,000, an increase of \$900,000 over the amount previously authorized to be expended; and (B) authorized such increase.

**WHEREAS,** the Town of Orwell is progressing its Water System Improvements Capital Project to update existing water system deficiencies by connecting to the Town of Richland water system, ensure continued system operations, and ensure public safety; and

**WHEREAS,** part of the Water System Improvements project includes the construction of a new booster pump station which shall include integration of a new instrumentation and control system to communicate with the existing Town of Orwell water storage tank system and with the existing Town of Richland integration and control system; and

**WHEREAS,** the Town of Richland instrumentation and control system has been designed, fabricated, furnished, installed, and maintained by AquaLogics Systems Inc. for the existing water treatment and well site; and

**WHEREAS,** the Town of Orwell finds it desirable to obtain the integrated SCADA controls for its Water System Improvements project through AquaLogics Systems, Inc., so as to maintain continuity of programming and equipment, efficiency, and economy with the existing Town of Richland system.

**NOW THEREFORE BE IT RESOLVED,** the Town of Orwell Town Board authorizes the standardization of the integrated SCADA controls for the Joint Water System to AquaLogics Systems Inc., as System Integrator for the instrumentation and control components for the Town of Orwell Water System Improvements Capital Project; and

## **BE IT FURTHER RESOLVED**, that this resolution shall take effect immediately.

- A) Asst. Water Operator Mike Pappa gave his report. Usage is around 15,000 gallons/day. The water levels are still good. The submersible burned up and has been replaced. Still waiting on the motor for system 2.
- B) CEO John Howland submitted a list of building permits and violations for the month of September.
- C) Highway Superintendent Henry went over the bills, repairs, and maintenance costs for the month of September. The Town Highway department took delivery of the dump box, plow, and wing. The truck will be going to Stadium International in Syracuse Wednesday October 11<sup>th</sup>. The Town should receive the truck next week. There is still no snow and ice contract with the Oswego County Highway Dept.
- D) Oswego County Legislator Herb Yerdon arrived at 7:19 pm and gave his report. All informational packets are on file in the Town Clerk's office.
  - Early voting locations will be held at the Board of Elections, 185 E. Seneca St, Oswego and the H. Douglas Barclay Courthouse, 1 Broad St, Pulaski Saturday Oct 28<sup>th</sup>, Sunday Oct 29<sup>th</sup>, Monday Oct 30<sup>th</sup>, Wednesday Nov 1<sup>st</sup>, Friday Nov 3<sup>rd</sup>, Saturday Nov 4<sup>th</sup>, Sunday Nov 5<sup>th</sup> 9am-5pm and Tuesday Oct 31<sup>st</sup> and Thursday Nov 2<sup>nd</sup> from noon-8pm.
  - Oswego County EMS sent a letter to Governor Hochul encouraging her to sign bill S1446A/A250 into law. It was unanimously supported and passed by the NYS Legislature. This bill will implement a streamlined process that would send health insurance payments directly to the ambulance provider.
- E) NOCA representative Bob Trainham gave his report. NOCA was up 17 calls from last year in September. They have responded to 1,807 calls total YTD. They are still within the budget for 2023.
- F) Tug Hill Representative Paul Baxter arrived at 7:26 pm and read his report as written.
