Supervisor Potter opened the regular meeting at 6:00 PM with the Pledge of Allegiance.

REPORTS:

A) Water Operator Eric Pappa gave his report. Water usage is around 12,000 gallons per day. The pump and motor should be here around February 21st. The pipe for the water project will be on site March 5th. If the weather is good construction will begin March 12th. Water Operator Eric Pappa asked Highway Superintendent Jon Roser if the construction company could park their work trailer at the Town Highway barn. They will need space until October. Superintendent Roser agreed.

B) CEO John Howland gave his report. CEO Howland asked for the board's approval to attend code school for training in April. The cost will be split among all the towns he works for. -A motion was made by Councilwoman Jessica Steele and seconded by Councilman Ryan Jones to approve CEO Howland's request to attend code school for training in April (5 ayes) Motion carries.

C) Highway Superintendent Jon Roser gave his report. Jake Teachout gave his two-week notice. The Town Highway barn now has an opening the needs to be filled. The Town traded the old roller for a new one and once the intermunicipal agreement is signed, it will be delivered to Williamstown.

D) Oswego County Legislator Herb Yerdon gave his report.

• Legislator Yerdon submitted a list of legislative committees and schedule of meetings, Fire Coordinator's year-end report for 2023, 911 center annual report for 2023, and the Public Safety Committee reports.

E) NOCA representative Bob Trainham gave his report. 215 calls in January. That is up 8 calls from January 2023. NOCA's administrative assistant Rachael resigned after 18 years. They are currently interviewing to fill the position. One ambulance has a bad transmission that needs repairing. The repair will cost around \$7,500 vs \$175,000 for a new ambulance. Two paramedics have left NOCA. One is pregnant and is unsure if she will return after the baby is born. The paramedics sent to school are working out well.

F) Tug Hill Representative Paul Baxter read his report as written.

DISCUSSION:

A. Solar Power Review:

As requested by Councilwoman Jessica Steele at the last meeting, Paul Baxter provided information to limit solar and wind energy in the Town of Orwell. The Town Board reviewed the documents and agreed to send the information to the Town Attorney Courtney Hills to review and draft a similar local law.

-A motion was made by Councilman William Garvin and seconded by Councilman Ryan Jones to send the solar and wind energy law from West Monroe to Courtney Hills for review and draft a similar law for the Town of Orwell. (5 ayes) Motion carries.

B. Water Construction updates:

Supervisor William Potter and Water Operator Eric Pappa met with Edge Construction from Parish to discuss the water project construction. Edge Construction was knowledgeable on the process and is ready to start construction in March if there is one foot or less of snow.
