Supervisor Potter opened the regular meeting at 6:00 PM with the Pledge of Allegiance.

REPORTS:

A) Water Operator Eric Pappa gave his report. Water usage is around 12,000 gallons per day. Still waiting on the pump. The laying of the main line for the water project began today. If all goes well the main line will be complete in three to four weeks.

B) CEO John Howland gave his report. Two permits were issued. There have been complaints of tires being dumped in numerous towns in the area. The transfer station in Pulaski now has a shredder and tires can be taken there year-round. Sayles VanRy asked who is responsible for cleaning up the tires that have been dumped over the bank on County Route 22 and CEO Howland responded that it was the responsibility of the property owner.

C) Highway Superintendent Jon Roser gave his report. Due to the unseasonably warm weather the highway crews will begin cutting trees on nice days and painting the plows on rainy days. Superintendent Roser has also posted all town roads as temporarily closed to any vehicle with gross load in excess of five (5) tons per axle.

D) Oswego County Legislator Herb Yerdon gave his report.

E) NOCA representative Bob Trainham gave his report. They are up 19 calls from the beginning of the year, with a 93.5% coverage rate. Three of NOCA's ambulances have high miles, however the cost of a new ambulance is around \$175,000.

F) Tug Hill Representative Heidi Tompkins read Paul Baxter's report as written.

B. Snowplow truck/USDA Financing Grant Application:

Supervisor William Potter is working with Tara from G&G to get a USDA Grant for a 2026 snowplow. The Town might be able to use some CHIPS money as a down payment. Highway Superintendent Roser needs a letter of intent to purchase a 2026 plow to lock in the price. The Town can back out at any time within the next two years.

C. Justice Audit/Review: Councilman David Lake volunteered to audit Judge Roser's books.

D. New Phone System: Due to the high volume of calls made to the wrong department and the time it takes to direct the caller to the correct department; Supervisor Potter has researched a phone system with an automated directory. Through Spectrum the new phone system will save the Town \$158.00 per month. Supervisor Potter is expecting to hear from Spectrum within the month about when they will be installing the new phone system.
