REPORTS:

A) Water Operator Eric Pappa gave his report. Water usage is around 12,000 gallons per day. There is 2600 ft of the main line left for the water project.

B) CEO John Howland gave his report. He will be in training Wednesday, Thursday, and Friday this week.

C) Highway Superintendent Jon Roser gave his report. The highway crews are off shifts and back to the regular schedule. They are working on switching the trucks from plows to dump trucks. Jon has someone interested in the full-time position that does not live in the Town of Orwell. Supervisor Potter asked the Town Board if they had any thoughts or concerns about hiring someone that does not live in the town. Councilwoman Steele would like to see the job offered to residents of the town first. Superintendent Roser replied that he had received multiple applications, and his primary goal was to hire the most qualified. Supervisor Potter, Councilman Jones, and Councilman Lake all agree the decision is Superintendent Roser's.

B. Water Construction Updates- The project is moving along quickly and due to the early spring, is ahead of schedule. The footers have been poured for the pump house and the walls will be done Friday. Once the pump station is online the tank will be drained and restored. The restoration will cost around \$93,000. Once the restoration is done, the pump station will pump the water to the tower and then use the tower's pressure to distribute the water throughout the water district.

C. Surplus (Non-Essential) property resolution/Hog Back landfill- Mark Palmer submitted a written request to purchase two lots, one 6.28 acres the other 1.74 acres, that the Town of Orwell owns on Hog Back Road bordering his existing property for \$6,000. It is the location of the old landfill and has been deemed safe to use by DEC. There is an ATV easement through the 6.28-acre parcel that Supervisor Potter feels the town should maintain. In the event of a sale, the purchaser would have to have that easement surveyed at their expense. Councilwoman Steele feels the price is not fair market value and should be countered. All Council members present agreed.
