A) Water Operator Eric Pappa did not attend.

B) CEO John Howland submitted a list of permits issued.

C) Highway Superintendent Jon Roser gave his report. A culvert on Stone Quarry washed out with the heavy rains and had to be replaced. The Highway department is hauling sand for winter and hopes to be done soon. Superintendent Roser heard from fellow Highway Superintendents that the snow and ice contract with Oswego County remains the same as last year. He has yet to see it in writing.

D) Oswego County Legislator Herb Yerdon submitted his report, and it was read as written.

**PUBLIC COMMENTS:** Residents from Jackson Road were in attendance to discuss the culvert and over flow trench near 194 Jackson Road. With the constant heavy rains the culvert was unable to handle all of the water in the creek and the overflow trench has become full of sediment, flooding the neighboring yards. Highway Superintendent Jon Roser commented that the culvert was replaced 15 years ago with a bigger culvert than what was previously there. Superintendent Roser will clean the over flow trench.
